BIDS FOR SALE OF CITY PROPERTY

The city had advertised a lot in Ralls addition and three lots on the east side of town near 9th avenue east. No bids were received. Amanda Huber was present and asked if the council would sell nine feet of the lot in Ralls addition. The lot is north of her property. A

motion was made by Michelle Berry to sell the property for \$150.00 to Amanda Huber. The motion was seconded by Sally Caudillo. On a roll call vote all voted in favor.

RECOMMENDATION FOR AUDITOR POSITION

The employment committee had interviewed Bailey Mathern for the position and was recommending that we offer her the position. A motion was made by Preston Sitzmann to hire Bailey. The motion was seconded by Michelle Berry. On a roll call vote all voted in favor.

RENEWAL OF GAMING SITE AUTHORIZATIONS

The annual renewal of gaming sites were received from Triple R Coteau for On the Rocks Bar and Grill and the American Legion for Hakuna Matata. Rick Gutschmidt made a motion to approve the two applications. The motion was seconded by Stefan Schoenfelder. On a roll call vote all voted in favor.

OTHER BUSINESS

Mayor Triepke was contacted by the Senior class for financial assistance with banners for Main Street. He said the Horse Club gave them \$500.00. The council decided not to provide financial assistance. He also reported that he was having the old library lot tilled and having grass planted. It was decided to have clean up week May 11th. Three candidates are on the Ballot for the city council and two candidates for park with three openings. Discussion on getting start on getting cleanup started with removal of abandoned vehicles and properties in poor condition. Discussion on delinquent water bills was held and it was recommended to enforce shut off notices when bills become delinquent.
