REGULAR COUNCIL MEETING
Wednesday, June 4, 6:00 PM

The meeting was called to order at 6:00 PM by Mayor Cal Triepke. Council members in attendance were Dan Schlosser, Stefan Schoenfelder, Jonas VanEnk, Preston Sitzmann and Sally Caudillo.. ARMORY HVAC BID AND PROJECT UPDATES

Ross Seefeld with the ND National Guard presented recommendations for altering the concrete plans approved previously. Motion made by Sitzmann, seconded by Caudillo to approve the change in plans according to the cost-saving measures presented. All voted in favor on a roll call vote, motion carried.

A bid from Mathern Heating and Cooling was presented to replace HVAC in the National Guard offices area of the Armory. Motion by Sitzmann, seconded by Schlosser to accept the bid of \$16,110.74 and proceed with the work. All voted in favor on a roll call vote, motion carried.

PERMIT APPROVALS

Motion by Caudillo, seconded by Schlosser to approve the on-site gaming permit for Triple R Coteau Horse Club in On the Rocks Bar and Grill.

OTHER BUSINESS

Arnie Middlestead requested dust control be applied to the street near his home. Motion by Caudillo, seconded by Sitzmann to extend planned dust control to include this area. All voted in favor on a roll call vote, motion carried.

City Attorney Radermacher presented information on updating ordinance regarding public comment at meetings and golf carts on city streets. She will prepare drafts of both ordinances to present for first reading in July.

Mayor Triepke adjourned the meeting at 7:08 pm.
